Community Pool Reminders

The weather is heating up and more and more residents are enjoying the community pool. Please keep in mind the following reminders for everyone's enjoyment:

- The pool is open from dawn to dusk.
- The pool area does have surveillance cameras, anyone at the pool after dusk is subject to being trespassed.
- Adult supervision is required at the pool for anyone under 14 years of age.
- Residents in good standing may use pool for a party by making arrangements with the HOA first. A \$25 cleaning deposit may be required.
- For everyone's safety, no glass or pets are allowed in the pool area.

 The pool is for the use of Indian Ridge residents and their invited guests only.

Thank you for following these guidelines so everyone can have a safe and pleasant time enjoying the pool.

Parking on the Apron Clarification

The HOA Board was informed by Code Enforcement and the Osceola County Sheriff's Office that parking lengthways on the apron of your driveway is only permitted if there is not a sidewalk running through your driveway. That clarification was not made when the ordinance was first being enforced.

The sidewalk makes the apron area to the street a county right of way (not an easement like those without a sidewalk) and therefore no parking is allowed.

Please remember that residents in need of a parking permit must follow the established process outlined below.

We are approaching one year since the Ordinance was passed and the deed restriction has been in place for 20+ years.

If you are not able to scan and send the form via email, just email us and we will arrange for the form to be dropped off or picked up so that you can obtain the permits.

Just a reminder that permits are only available for on street parking from 8am to 2am.

See a CODE VIOLATION?

Code enforcement has been successful in getting boats/vehicles/etc off of the grass areas and is continuing their efforts to clean up the neighborhood. Please note that the process in not a fast one, but seems to be getting done. We would ask that you not only report violations to the HOA email, but to County Code Enforcement as well. We realize that there are a great many dog lovers in this world. Dogs enrich the lives of all who come in contact with them. However, there comes a time when having dogs becomes a nuisance, and an interruption to the peaceful quietness of our neighborhood. Owners show a lack of consideration for others when their dogs are left to bark incessantly. Some people feel that they can leave their dogs outside,

on the back porch, or in the garage. This is unacceptable. So, homeowners of Indian Ridge, please curb your dogs, and please recognize other people's wishes to have a quiet evening and an undisturbed nights sleep.

Dog owners, PLEASE ensure that your pets are always on a lease and most importantly, please clean up after your dog. IT IS THE LAW! Dog poop is NOT good fertilizer. It's toxic to your lawn! It is unfair to allow your dog to poop on other people's property or on the common areas. Also, the U.S. Center for Disease Control and Prevention (CDC) confirms, "...pet waste can spread parasites including hookworms, ringworms, tapeworms and Salmonella. When infected dog poop comes into contact with your lawn, the poop will eventually "disappear", but the parasite eggs can linger for years!"

Also keep in mind that the Osceola County Land De-

velopment Code has standards surrounding Yard Sales.

Land Development Code, Chapter 3 - Performance and Siting Standards, Article 3.3 — Property Performance Standards, Section H — Garage/Yard ETC. Sales Which States: Garage, yard, tag, patio, and apartment sales are specifically permitted, as an accessory use, in all residential and mixed use districts. SUCH SALES SHALL BE LIMITED TO ONE DURING EACH SIX (6) MONTH PERIOD, FOR DURATION NOT TO EXCEED THREE (3) DAYS.
